II. Diversity Visa 2021

As with immediate relative and family preference immigrant visa categories, the following chart demonstrates that Defendants continue to process DV-2021 cases in ever-increasing numbers as post capacity permits. Although not required by the April 15 Minute Order, Defendants report that similar progress can be seen in other areas of DV processing; Defendants report that as of May 18, 2021, a total of 13,705 cases, representing 28,460 applicants, have been determined to be documentarily qualified.
